- b. The Service Audit Policy.
- c. The Service OASO Policy.
- d. Supporting Incident Command Assessments.
- 3. To recognise and support opportunities for Joint Organisational Learning and to monitor/review outcomes from other national fire & rescue service(s) debriefs/investigations.

- 4. To recognise and support outcomes/information from the Health and Safety Executive; seeking opportunities to continually improve policies and procedures against HSG65.
- 5. To plan, lead, implement and conduct Station audits.
- 6. Support the analysis of operational information against policies, business plans and Key Performance Indicators; to evaluate and report to the Operational Assurance Group.
- 7. To support the integration of Incident Command Verifications, in particular between the OCAT and the OA Dept. with the view to maximize learning throughout the organisation.
- 8. To provide support and guidance to all officers operating in the role of an Operational Assurance and Support.
- 9. To provide operations expertise, experience and knowledge to effectively develop and review operational assurance guidance, policy and strategy; and play a key role within the consultation process to support this.
- 10. Support departmental contributions to the Services Strategic plan/direction
- 11. Support request for information, advice and guidance to key stakeholders relating to the range of operational assessment and assurance systems.
- 12. To deputise as required for the Operational Assessment and Assurance Manager in attending and participating in regional and national operational assurance groups/activities. Liaising with other Fire and Rescue Services and outside organisations, encouraging and supportive of the adoption of recognised 'best practice'.
- 13. Support and engage with internal and external stake holders on the identification and development of Operational Assessment and Assurance priorities and planning.
- 14. Positively contribute to a safe work environment ensuring compliance with Health and Safety, Risk Management, Business Continuity and Safeguarding policy and procedure. Protect all personal information in adherence with the Data Protection Act 2018.
